## **LOCATION:**

The property is located on Jordanstown Avenue in Greenogue Business Park. Greenogue Business Park is one of the largest business parks in Southwest Dublin.

The location of the property is considered prime just 1.1km from the Rathcoole Interchange on the N7.

## **DESCRIPTION:**

The subject property comprises a semi-detached, steel portal frame warehouse with a dock leveller to the front and a Grade door to the rear.


